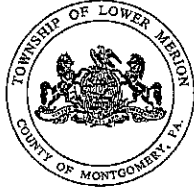

The Township is in receipt of your records request dated August 31, 2017 seeking "Any and all billings and payments in relation to Firearms Owners Against Crime, et al. v. Lower Merion."


