STIPULATION OF THE PARTIES



1. Chief Deputy Attorney General Karen Romano is an attorney with the Pennsylvania Attorney General’s Office, who was authorized to accept service of the Petition for Review on behalf of Respondent Commissioner Paris and accepted service on June 20, 2023.
2. Attorney Joseph Walsh of Walsh Pancio, LLC is the solicitor for Respondent Sheriff Kilkenny, who was authorized to accept service of the Petition for Review on behalf of Respondent Sheriff Kilkenny and accepted service on June 20, 2023.

3. Given the legal issues raised in the Petition for Review and to allow this Court sufficient time to review them, Respondent Sheriff Kilkenny agrees to stay enforcement of his recently announced policy of inspecting Pennsylvania License to Sell Firearm licensees,¹ and to this Court issuing the attached order related thereto.
